Norwegian poisons information centre

- Collecting information and giving advice since 1961
 - 24/7 since 1993
 - Open for public and health care professionals, and anyone else
 - One call staff is: pharmacists, veterinarians, doctors and toxicologists. Same staff doing the scientific work: litterature surveillance, reviews etc

- The PC and I
 - Since 2001
 - Working with CLP art. 45 and annex VIII for about 10 years
 - PCN




The hotline

- Approx 47 000 calls annually
- 1 or 2 people answering calls

Average call time 4 minutes

- Caller tells me what has happened
- I ask follow up questions
- I find product info (composition)
- I assess the product composition for toxicity, and in relation to the exposure
- Decide on what action, if any, is needed
 - Tailored to the specific exposure, patient, place, time of day etc
- Treatment advice is explained to the caller

I need to find product info in < 1 minute
